## MSP Settlement

We want to share an update with you regarding the “Nuisance Lawsuit” against the NCM by the Crump family.

We are pleased to let you know that a settlement agreement has been reached with the family. The main issues that were agreed to include:

- The NCM will purchase the real estate located at 192, 198 and 278 Grimes Road. This is the 3 houses, the saddle shop and a total of 16 acres located on the right at the entrance to the MSP.
- Closing on or before 7 months.
- Both parties agree to not disparage or otherwise make public comments against the other party now or in the future.
- An Agreed Order of Dismissal for all claims asserted in the lawsuit shall be entered in the Warren Circuit Court.

This settlement allows the MSP staff to move forward with the recent momentum generated from the opening of the Karting or Kart Plex --- the 5 new Corvettes purchased and available for touring laps and the Corvette Experience --- and the two new Camaro’s.

This is an exciting time for the MSP and also the NCM.
